If you want to get faster at LR, identifying the question stem more quickly is an easy way to shave 30 seconds off your time. That's why I'm uploading a bonus question stem quiz solely focused on timing.

Before you take this quiz, study The Fast and The Question Stem Quiz from The Loophole in LSAT Logical Reasoning and review your weaker areas. Obviously, you're going to know the question stem when it's something like "Which of the following weakens the argument?" But you should make sure you know the more complex stems before you take this quiz. This quiz is timed (gasp).



Another question stem quiz, another forced reference to The Fast and the Furious. I am nothing if not consistent.

INSTRUCTIONS

Start a stopwatch and then identify each of the following question stems out loud; say whether it's powerful or provable out loud as well. Do not write down the question type and whether it's powerful or provable on your first pass. The goal is to see how fast you can identify the question stems. If we factor in how long it takes you to write out names, it screws up the data. After you've finished your out loud identification, stop the stopwatch. Write in your answers so you can check them.

For example, if I read, "Which of the following weakens the argument?" I would say, "Weaken Powerful" out loud and then move on to the next question stem. After finishing the entire drill and stopping the stopwatch, I would write all the identifications in the blanks so I can check my accuracy.
